

Openbare Kennisgewing

Geleentheid vir Herleiding en Veredeling van Soliede Munisipale Afval by die NMBM

Die NMBM is verbind tot die vermindering van Soliede Munisipale Afval (SMA) wat na stortingssterreine verwyder word en tot die veredeling van afval. Die NMBM stel hom ten doel om dit te verweselik deur die implementering van 'n geïntegreerde Afvalherleidings- en Veredelingsprojek wat verskeie voordele vir die Munisipaliteit inhou.

Daar word beoog dat die Projek uit twee fases sal bestaan:
Fase 1 behels die ontwikkeling van die "Ondersteunende Infrastruktuur": MRF en Vullisoordrastie (RTS) infrastruktuur.
Fase 2 behels die oprigting van 'n "Afvalpark". 'n "Afvalpark" is 'n begrip wat gebruik word om 'n geïntegreerde Afval- en Hulpbronbestuursaanleg te beskryf wat op 'n enkele stuk grond geleë is en ontwerp is om nuttige hulpbronne en energie te herwin uit afval wat ontvang, hanteer, verwerk, oorgedra en behandel word.

Op 14 Desember 2015 het die NMBM-raad besluit om afgekondigde prosesse te onderneem vir die implementering van 'n Afvalherleidings- en Veredelingsprojek deur 'n oplossing wat 'n Openbare-Private-Vennootskap (PPP) behels en om 'n langtermyn (>20 jaar) verkrygingsooreenkoms met 'n gevestigde Tegnieëse Vennoot vir die projek aan te gaan. Dit is dus van die uiterste belang dat daar tydens die projekprosesse aan die volgende Wetgewende Vereistes voldoen word:

Ingevolge die Wet op Plaaslike Regering: Munisipale Finansiële Bestuur [MFMA] (Wet 56 van 2003):

- Artikel 33 en Artikel 120 vereis oorlegpleging met die gemeenskap en belangstellende persone met betrekking tot die beoogde kontrak en Openbare-Private-Vennootskap.

Ingevolge die Wet op Plaaslike Regering: Munisipale Stelsels (Wet 32 van 2000) (soos gewysig):

- Artikel 78 vereis kennisgewing en oorlegpleging met die gemeenskap en georganiseerde arbeid vir beoogde eksterne meganismes vir diensverskaffing.

Ingevolge die Nasionale Wet op Omgewingsbestuur [NEMA] (Wet 107 van 1998) (soos gewysig) en die OIE-regulasies (2014):

- Openbare Oorlegpleging maak 'n integrale deel van die Omgewingsmagtigingsproses uit.
- Die vereiste prosesse met betrekking tot Omgewingsverslagdoening sal met verloop van tyd onderneem word.

Derhalwe onderneem die NMBM 'n Openbare Deelnameproses ten einde aan die wetgewende vereistes te voldoen.

Public Notice

Municipal Solid Waste Diversion and Beneficiation Opportunities at the NMBM

The NMBM is committed to minimising Municipal Solid Waste (MSW) disposed to landfill and beneficiating waste. The NMBM aims to achieve this through implementing an integrated Waste Diversion and Beneficiation Project which has several advantages to the Municipality.

The Project is envisaged to comprise two phases:
Phase 1 comprises the development of the "Enabling Infrastructure": MRF and Refuse Transfer Station (RTS) infrastructure.
Phase 2 comprises the construction of a "Waste Park". A "Waste Park" is a term used to describe an integrated Waste and Resources Management Facility located on a single plot of land, designed to receive, handle, process, transfer, treat and recover useful resources and energy from waste.

On the 14th December 2015 the NMBM Council resolved to undertake legislated processes for implementation of a Waste Diversion and Beneficiation Project through a Public-Private-Partnership (PPP) solution and enter into a long-term (>20 years) procurement agreement with an established Technical Partner for the project. The following Legislative Requirements are therefore of utmost importance to be adhered to during the project processes:

In terms of the Municipal Finance Management Act [MFMA] (Act No. 56 of 2003):

- Section 33 and Section 120 require consultation with the community and interested persons with regard to the proposed contract and Public-Private-Partnership

In terms of the Municipal Systems Act [MSA] (Act No. 32 of 2000) (as amended):

- Section 78 requires notification and consultation with the community and organised labour for proposed external mechanisms for service provision

In terms of the National Environmental Management Act [NEMA] (Act No. 107 of 1998) (as amended) and EIA Regulations (2014):

- Public Consultation forms an integral part of the Environmental Authorisation process
- The required Environmental Reporting processes will be undertaken in due course

It is for this reason that the NMBM is conducting a Public Participation Process in order to fulfil the legislative requirements.
