

## WEB-BASED REGISTRATION OF WASTE TRANSPORTERS

**NOTE: Health Care Waste (HCW) transporters /generators/disposers must register in terms of Chapter 8, part 3 of the NMBM Municipal Health By-laws on not in terms of Chapter 3 of the Nelson Mandela Municipal Waste By-law**

**Read More:** Here you can get more information about the registration, who should register, definition of waste and Chapter 3 of the Nelson Mandela Municipal Waste By-laws relating to the registration of Waste Transporters within Nelson Mandela Bay Municipality.

**Register Now:** Here you can registration as a Waste Transporter, if you are not yet registered

**Forgot password:** Use this function if you cannot remember your password

**Search Waste Transporter Database:** Here you can view the registered Waste Transporters with Nelson Mandela Bay Municipality. All registered companies will be listed on this Waste Transporter Database

**Login:** Registered Waste Transporters can log in to the system to view your registration details (use login name and password that you received)

If the web-based registration was done by Nelson Mandela Bay Municipality, on your behalf, you are requested to check your details and make the necessary changes.

**Update:** Should any of your details change you are requested to login and keep your details up to date

**De-Register:** Should you wish to remove your business as a legal Waste Transporter you can login and follow the link which will request you to send an email with the reason and the de-registration will be done by the Administrator

**IMPORTANT TO NOTE:**

**THIS IS A ONCE OFF REGISTRATION AND FREE OF CHARGE.**

**This registration must not be seen as an opportunity to do work for NMBM, as this registration is a legal requirement in terms of Chapter 3 of the Waste By-laws.**

**When companies and individuals make use of transporters, they have to ensure that only registered transporters are used.** See Chapter 3, Section 30 (2) of the Nelson Mandela Bay Municipality's Waste Management Bylaw.
